2022 marks 25 years that the John Muir Community Health Fund has been crafting initiatives that support the health and health care of our friends and neighbors in Central and East Contra Costa. More than ever before, we see a need to continue and deepen our commitment to collaborate with the underresourced communities that we serve.

We foster lasting partnerships with community nonprofit organizations to address many of the factors that threaten good health throughout people's lives, from lack of access to quality care through systemic racism and food insecurity.

This commitment stems from an ever-growing understanding of the many factors that contribute to health and wellness. When we began, our focus was supporting organizations that delivered direct medical care, but over time our vision of

grantmaking evolved. Today, we foster lasting partnerships with community nonprofit organizations to address many of the factors that threaten good health throughout people's lives, from lack of access to quality care through systemic racism and food insecurity.

In practice, this vision has meant relentless questioning, learning, challenging ourselves to revise our views, and thoughtfully incorporating all that we have learned. As an example, this year, we attended a series of board retreats and community discussions that have provided us with the opportunity to generate a racial equity statement that commits us to a new level of community engagement. This statement holds us accountable to ensure that the work we support is closely aligned with what each community knows it needs.



The map above indicates areas in East and Central Costa County where healthcare and wellness services were previously lacking and where the CHF has played a role in supporting community partners that provide those vital services. In the last year alone, CHF-supported community partners have delivered these services to an estimated 247,000 people, out of a total population of approximately 381,000. We have been especially focused on the shaded areas, which represent people most in need of health and wellness services; the darker the shading, the greater the need.

# Briana Rodriguez Comes Home to Support Antioch Youth

Because mindfulness can be an important strategy for addressing mental health and behavioral challenges in children, the CHF has been instrumental in helping Mindful Life Project (MLP) expand to schools in East and Central Contra Costa County. Briana Rodriguez, who became a mindfulness coach for MLP in 2021, spent the school year working with students at the Antioch elementary school she once attended. This is her story.

Over time, the students realized I was a trustworthy adult, someone who grew up and lives in this community.

My family and I emigrated from Mexico to Antioch in 1998, looking for opportunities. My educational trajectory began at Marsh Elementary, Park Middle School and Antioch High School. I knew I would go to college but wasn't sure how I would get there. My high school counselors and teachers paved a way. I graduated from Sonoma State with a dual major in Psychology and Chicano/Latino Studies and studied the effects of micro-aggressions on women of color. This helped me embrace my identity as a queer Latina immigrant woman. Then I went to Fresno State where I got my masters in 2021, in higher education administration and leadership. I almost went back to college counseling, but decided to explore opportunities in my home community.

A friend introduced me to MLP where I found inspiring people doing great work. When [Executive Director] JG [Larochette] asked if I wanted to work at Marsh, it was a chance to serve the community that set the foundation of my educational trajectory.

Over time, the students realized I was a trustworthy adult, someone who grew up and lives in this community. Marsh students have many talents, but don't always feel seen and heard. With mindfulness, they've found many different ways to use their voices. We do a lot of different things - art, music, movement, dance - because we're always looking for another way to communicate.




